Hospice providers that furnish services to MO HealthNet participants in a nursing facility will be reimbursed 95% of the nursing facility's per diem rate for room and board. Hospice providers operating in nursing facilities without a final rate are also subject to retroactive settlement.

1) The Medicare hospice final rule replaces the single RHC per diem rate with two different RHC payment rates, a higher payment rate for the first 60 days of hospice care, and a reduced payment rate for 61 days and over of hospice care.
