Real property with a tax year three (3) or more years delinquent is subject to foreclosure. To redeem the property after foreclosure proceedings begin, 2017 and prior years' taxes, interest, penalties, and foreclosure costs must be paid (RCW 84.64). A minimum bid will be solicited for each property.
